# Annenberg Public Policy Center 2022 Constitution Day Survey

#### **SURVEY METHODOLOGY**

The 2022 Annenberg Civics Survey was conducted for the Annenberg Public Policy Center via telephone (CATI) by SSRS, an independent research company. Interviews were conducted **August 2 – August 13**, **2022**, among **1,113** U.S. adults, aged 18 and older. Respondents were drawn from a national probability sample in all 50 states. The dual frame sample included 889 cell phone respondents and 37 respondents who completed the survey in Spanish.

Data were weighted to represent the target U.S. adult population. The adjusted margin of error for total respondents in the sample is  $\pm -3.58\%$  at the 95% confidence level. The design effect is 1.48. Totals in the topline may add up to either greater than or less than 100% due to rounding. For more information on the methodology click here.

Results are reported as percentages. Because percentages are rounded, they may not total 100%. Overall and net percentages may not exactly match sum of corresponding percentages.

Linear regression: Taking a high school civics class as a predictor of civics knowledge items (controlling for sex, age, education, race, and political ideology)

We created a knowledge index comprising five items: 1) correctly naming all three branches, 2) correctly naming First Amendment rights, 3) saying it is inaccurate that the First Amendment says Facebook must permit all Americans to freely express themselves on Facebook pages, 4) saying the Supreme Court has the final say about whether a law is constitutional, and 5) knowing the meaning of a 5-4 Supreme Court decision.
