

**2015 Constitution Day/Civics Study
Annenberg Public Policy Center**

**TOPLINE RESULTS
August 31, 2015**

The study was conducted for Annenberg Public Policy Center via telephone (503 Landline and 509 Cell Phone Interviews, with both English and Spanish Respondents) by SSRS, an independent research company. Interviews were conducted from **August 27 – 31, 2015** among a sample of **1,012 total respondents**. The margin of error for total respondents is +/- 3.7% at the 95% confidence level.
